1. A non-refundable deposit of \$200 shall accompany this application.
2. Payment is due in full upon registration, or by setting up an automatic payment plan in the registration portal.
3. **REFERRAL DISCOUNT!!** \$100 off your tuition for each new family you refer that signs up for at least 2 weeks! A "new family" is considered a family who has not attended Gan Israel of Roslyn since 2016. They must indicate you as their "referrer".
4. **Sibling Discount:** 5% off total family base tuition – not optional programs. Discount only applies for full 6 week enrollment.
5. **Shirt & Hat Fee:** \$15 per child will be added to your total tuition to pay for the official Camp T-shirt and hat. Camp T-shirt must be worn on trip days (-tentative). Child not wearing camp shirt on a trip day will be given a new one and charged \$10.
6. **Regular Refund Policy:** In the event of camper withdrawal from program, tuition total will be recalculated according to number of weeks attended (partial week counted as "week"), based on "Individual Weeks Rate" at time of withdrawal, and refund will be issued accordingly. No credit or refund will be granted for absent days. In the event of full consecutive 'camp week' (Monday-Friday) or more of absence, refund will be granted as above.
7. **Special Covid-19 Cancellation & Refund Policy:**
 ~Until June 22: Full refund available for any reason, no extra fees.
 ~After June 22: Full refund minus \$200 deposit, until 7 days before session start date.
 ~No refunds available from 7 days before session start date.
 In case Camp Gan Israel will be forced to cancel or temporarily close a program due to a Covid infection, Camp Gan Israel will offer a full refund for unused days (prorated) to all those campers affected. Only those campers (and siblings) who are directly affected by the closure will be offered a refund.
8. The camp reserves the right to terminate enrollment of any camper who does not demonstrate reasonable age appropriate standards of behavior (as determined by the camp). Refund will be calculated as above.
9. A completed medical form shall be in the possession of Camp Gan Israel before beginning of camp. By order of the Health Department, a child will not be allowed in camp without a completed medical form on file.
10. In case of medical emergency, camp staff has permission to treat camper as deemed appropriate.
11. Permission is granted to use photographs and videos taken of children for promotional purposes.
12. Consent is granted to take child off camp grounds for swimming and excursions, as part of camp activities.
13. Camp staff has authority to sign, on behalf of parent or guardian, any waivers required to participate in scheduled trips & activities.
14. Camp Gan Israel operates with a permit from the Nassau County Department of Health, and is inspected twice yearly. Reports are filed and are available at 200 County Seat Drive, Mineola, NY 11501, Mon-Fri. 9am-4:45pm.
15. This contract is to be considered valid and binding when signed electronically in the online registration portal by parent or guardian.
